

## Loudoun Transmission Line Alliance Update



Federal proposals for new transmission lines threaten to put large transmission towers across our area of Loudoun County. Proposals have lines running down the Catoctin Valley, with earlier proposals having them running right down Catoctin Creek. On May 8th, the U.S. Secretary of Energy included parts of Loudoun county in the first step of identifying new National Interest Electric Transmission Corridors. A NIETC designation provides an expedited permitting and construction process for transmission lines. [\(read more\)](#)

# Rural Roads Bill Passes

## UNPAVED SECONDARY HIGHWAY FUNDS

The Bill clarifies that the improvement of non-surface treated secondary highways includes improvements other than paving, as described in the bill. The bill also clarifies that the local governing body of the county receiving funds for such improvements will select the highways or highway segments to be improved, after consulting with the Department of Transportation. This bill is identical to [SB 644](#).

# Rural Historic Villages Planning Begins

## HELP ENVISION A RENEWED TAYLORSTOWN VILLAGE

The Board of Supervisors has approved a framework to begin updating the Rural Historic Village designation and classification criteria. At the end of the project, the county expects to have an updated list of rural historic villages, surveys for all existing villages, an internal classification system based on the criteria for designation, revised maps and text for the 2019 General Plan, revised maps and text for the zoning ordinance, and revised GIS layers.
